



USER FEE SCHEDULE



PROCESSING FEE - A \$10.00 fee will be charged to boaters not using their current renewal card. A \$5.00 fee will be charged to new applicants filling out the form for the first time. Temporary permits are exempt.

OUT OF STATE FEE – A fee of \$40.00 per permit will be charged for boats registered out of the state of Illinois. One-day & ten-day permits are exempt. Proof of state registration may be required.

CLASS X - Non-motor-powered boats 17 feet or less in Length (Paddle Boards do not require a sticker) \$15.00

CLASS L (Livery boats) - a fleet of 10 or more boats less than 17 feet in length and less than 25 HP. Office purchase only - Applies to commercial use only \$40.00

CLASS A - Motor powered boats of 15HP or less and non-motor-powered boats more than 17 feet in length \$50.00

CLASS B - Motor powered boats and jet skis over 15 HP (not exceeding 25 feet in length) \$100.00

CLASS C - Motor powered boats over 15HP and greater than 25 feet in length (not exceeding 30 feet) \$170.00

CLASS D - Transferable plate for dealers and two or more antique boats (30 or more years of age) \$170.00

CLASS E - Motor powered boats over 15 HP and greater than 30 feet in length \$210.00

CLASS W - Any boat involved in waterfowl hunting activity, WITHOUT A CURRENT STICKER. (Available August 15 - December 31, yearly. A current valid hunting license is required to purchase a sticker, as well as any applicable out-of-state fees.) \$35.00

COMMERCIAL ENDORSEMENT – An additional fee will be charged to any commercial boat using the system for business purposes, including but not limited to towboats, working boats, barges, tours, party boats, food boats, fishing guides, and rental boats. Office purchase only.

LOST STICKERS - The holder of a User-Fee Sticker that has been lost, shall be re-issued a User-Fee Sticker for the balance of the year upon the filing of an application and payment of a \$15.00 fee. Proof of original purchase is required.
(Please Note: Lost stickers can only be processed at the Fox Waterway Agency Office)

TRANSFER POLICY - There is a \$5.00 charge for a transfer in addition to any charges for an upgrade in class. Applies to the original owner only. **Original stickers must be presented when applying for transfer**

DUPLICATE PURCHASES - Refunds requested for duplicate permit purchases for the same boat and the same owner, shall be issued upon proof of duplicate purchase and the return of one permit in reusable condition. The refund will be for the sticker fee-only, less a \$15.00 fee. **Requests for refunds must be made within 30 days of purchase.**
(Please Note: Duplicate stickers can only be processed at the Fox Waterway Agency Office)

REFUND POLICY - NO REFUNDS - will be issued after April 1st of each boating season.

RETURNED CHECK POLICY - A \$30.00 fee will be applied to all returned checks.
